TRANSPORTATION WAIVER

If you have a student that has signed-up for a program at The Kroc or attends either Lakes, Canfield, or Woodland Middle Schools, they are eligible for free after-school transportation. If your child would like to participate in the free after-school transportation program, we will contact you to verify your information and let you know if they are on the roster. I understand that if my child un-enrolls/does not attend the Kroc Program, he/she will no longer be eligible for free transportation.
